APPEAL APPLICATION INSTRUCTIONS

> Only residents within Permit Area I or Permit Area V are eligible to appeal for an additional parking permit sticker. This application must be completed by the primary resident of the address. A maximum of two permit stickers per household may be purchased without appeal. A maximum of one (1) visitor hangtag will be issued per household with a minimum purchase of one (1) permit sticker. Appeals for additional visitor hangtags will not be approved. Neighborhood associations may be consulted for input before an appeal is decided. Decisions of the Director of Public Service are final.

Appeals for additional permit stickers may be considered under the following conditions:

- * The appellant does not own, lease, or otherwise have access to off-street parking serving the household; or
- \div More than two licensed drivers reside at the address and more than two vehicles are registered to the address; and
- * Residents at the address provide acceptable proof of residency (current lease or mortgage; current electric, water, gas or landline telephone bill; signed and notarized affidavit of residency signed by primary and additional residents)

Appeals for additional permit stickers will not be approved for the following instances:

- \Leftrightarrow Appeals for households at 641 North High Street
- * Appeals for households with off-street parking used for purposes other than parking vehicles will not be approved
- $\dot{\mathbf{v}}$ Appeals for households with two or fewer licensed drivers residing at the address

A resident may submit a completed appeal application to ATTN: Parking Services Support, Parking Violations Bureau, 2700 Impound Lot Road, Columbus, Ohio 43207, Monday – Saturday, 9 AM to 7 PM, excluding holidays. Appeal applications may also be mailed to the Parking Violations Bureau. Applicants will be notified of appeal decisions by email and/or US mail.
