Procedure for Verifying Zero Rating Approval Letters Online

Effective February 9th 2015, TAJ has started issuing Zero Rating Approval or Rejection Letters as part of the Zero rating Process.

Suppliers who need to verify the validity of Zero Rating Letters can now do so online.

To access this service, the Supplier will be required to complete the following steps:

- 1. Visit TAJ's Enterprise Portal (www.jamaicatax.gov.jm) and create a new user name and password. This can be achieved by clicking the "Client Login" link followed by clicking the "Create Account" link.
- Suppliers who already have a login can access the system with the user name and password previously created.
