

Subject to the provisions of the 'old part' section 31A, subsection (1) of the Bermuda Immigration and Protection Act, 1956, a person may apply to the Minister for the grant of a permanent resident's certificate if:

- he was ordinarily resident in Bermuda on or before 31 July 1989;
- he has been ordinarily resident in Bermuda for a period of 20 years;
- he was ordinarily resident in Bermuda for a period of two years immediately preceding the application;
- · he is, on the date of application, not less than 40 years of age; and
- he makes application before 1 August 2010.
